



Children's System of Care

Children's System of Care (CSOC) can provide access to a broad array of in-home and community-based treatment services and other supports for youth and their families. The continuum of care includes assessment, in-home treatment and support services, and out of home treatment services for youth who may benefit from a more intensive treatment setting.

All services are based on the youth's clinical needs. Some services require referral through the youth's Care Management Organization (CMO) to request authorization.



Treatment & Support Services

The **Children's System of Care (CSOC)** serves families with youth up to 21 years of age who have emotional or behavioral health needs, including substance use disorders, and/or intellectual and developmental disabilities.

Through CSOC's contracted system administrator (CSA), parents or guardians can be connected to appropriate services for their child. CSA provides a path for families to request appropriate therapeutic, needs-based services with a single phone call any time of the day or night.



CHILDREN'S SYSTEM OF CARE

The **Children's System of Care**, a Division of New Jersey's Department of Children and Families, provides timely and individualized support and services to youth with emotional and/or behavioral challenges, substance use disorders, and/or youth with intellectual/developmental disabilities.

Through a single point of entry, New Jersey's eligible youth and families can obtain behavioral health, substance use treatment, and developmental disability services.

Mobile Response & Stabilization Services

Mobile Response and Stabilization Services (MRSS) can provide timely, in-home or in-community response to youth who are experiencing or at-risk of experiencing a crisis, as defined by the family. MRSS will arrive within one to 24 hours, based on the urgency of the family's need and request for assistance. The goal is to de-escalate as necessary, engage, assess, plan for and connect families to services that address youth and family needs, stabilize the youth's emotions and behavior, and support the youth's ability to remain at home and function within school and community settings.

Care Management for Complex Needs

Care Management Organizations (CMOs) are county-based agencies that provide strength based, wraparound care planning and access to treatment and support services for youth and their families with complex needs. Their work includes individualized service planning for youth and their families, creating linkages to identified services, crisis stabilization and support services, and advocacy. Each CMO maintains county **ResourceNet**, a free online directory of programs, supports, services, and events for families available in each county.

Peer Support, Education & Advocacy

Family Support Organization (FSOs) are non-profit, county-based organizations run by families of youth and young adults with emotional and behavioral challenges, substance use treatment needs, and/or intellectual and developmental disabilities. FSO services include:

- **Advocacy**
- **Youth and caregivers support groups**
- **Educational support groups**
- **Individual peer support for families of youth enrolled with Care Management Organizations (CMO)**

FSO supports are also available to families without involvement in CMO or Mobile Response and Stabilization Services (MRSS).
